However, let's not forget that there are numerous other folks who contribute in big ways; and that they are appreciated. The remainder of 2024 and 2025 should be very successful and good times for our branch.

Speaking of the future, I indicated that as soon as I learned anything from the state that I would share and keep you informed. So in that spirit, I went to their meeting in Lafayette on 9/24. There were about 100 folks there from numerous branches. A very quick officers' election was held and then there were a few different speakers including our President Rich Carlston. Prior to that, Andy Danver gave a very interesting talk about the history of SIRS concluding with where we are now...in a steady decline, basically aging out. This board felt that had to do something and came up with some ideas/proposals. They then spoke about the last "town hall" meeting at which they had voiced these proposals. As I mentioned in the August Newsletter some of those proposals included:

- * A name and logo change. Take away the word "Retirement" and possibly "Sons";
- *Transition to 501(c)3 nonprofit, soliciting donations, and hiring an executive director, a digital marketing firm, and an IT firm.
- * In order to obtain desired donations, the Inclusion of women.

In the following months, the state board heard from many branches who were generally not impressed with most ideas. The bottom line is that they've gone back to the drawing board, but were happy to have heard from the branches. The state speakers made it clear that they fully understand that not all branches are the same, and what fits for one, may not fit for another...but doing nothing isn't a real option either. So here's what is going to happen. President, Rich Carlston is forming a "SIR Branch Advisory Council to "help the Board of Directors"

establish the strategic direction and develop the implementation plans to sustain SIR". They will probably start their zoom meetings in about October; perhaps 2-3 meetings per month. If no one from a branch volunteers, then that Branch's wishes will not be considered. Hence, since I am the incoming Big Sir, and changes may be coming in 2005, I volunteered. It is clear that we should NOT expect any changes during the next six months.

I believe it important that if I am going to represent this branch, then I must understand our members' opinions. Please expect controlled short discussions at our monthly meetings with perhaps a show of hands as to opinions....Another good reason not to miss the monthly meetings/luncheons.

Recruitment: We still have a goal of at least 80 members by year's end, <u>3 more to go</u>, so let's spread the word.


For Coffee (John Fineren): Interest in the Tuesday Morning 9am coffee session is very busy. Please don't forget to invite a friend.

Presently, there are vacancies on some of the teams. For the first time bowlers who join us, the fee is \$21.00, including \$17.00 for the weekly fee and \$5.00 for the prize fund to be distributed at the end of the season,. Also, the first day a new bowler bowls with us will be to establish a handicap. Handicaps are based on the difference between 220 and your average over the first three games. In other words, 220 minus your first three game average equals your handicap. Handicaps are adjusted down or up throughout the season to keep track of your weekly average scores above and below your handicap. 



Youth and seniors can still ride free on SMART trains throughout Sonoma and Marin counties under a new pilot program that started April 1.

According to a recent announcement, the program runs through June 30, 2025, and allows youth 18 and younger and seniors 65 and older to board any SMART train, any day of the week and ride fare-free. Youth and seniors are not required to have a Clipper Card or to use the SMART eTickets app, to reduce any barriers to entering the transit system.
